Beleggingsdoelstelling

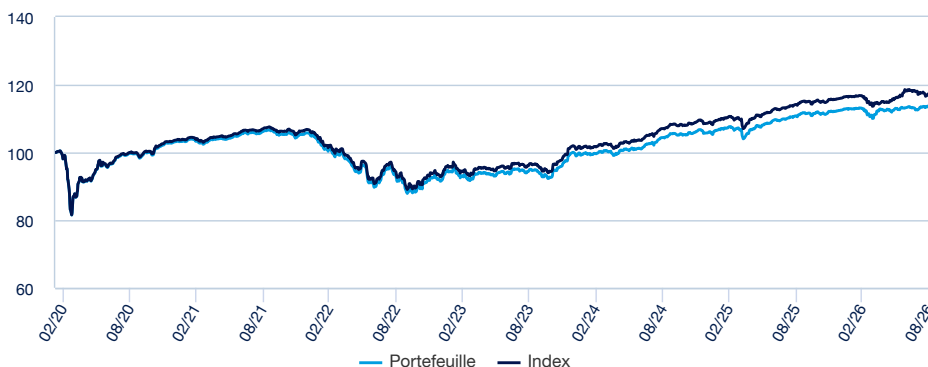

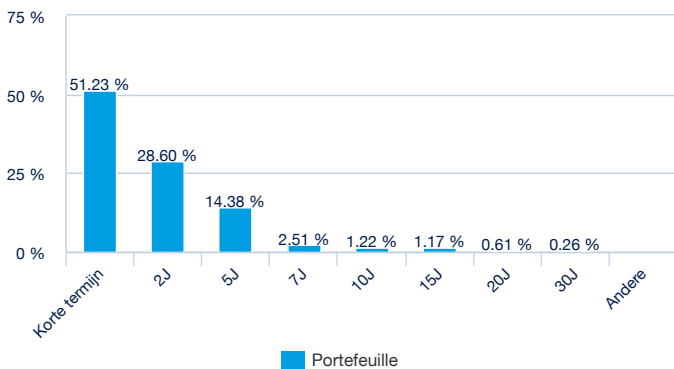

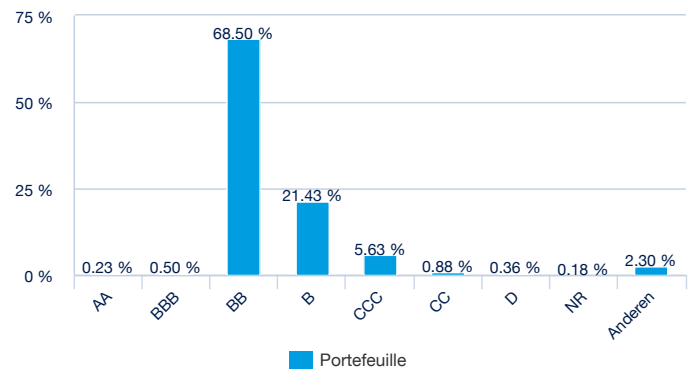

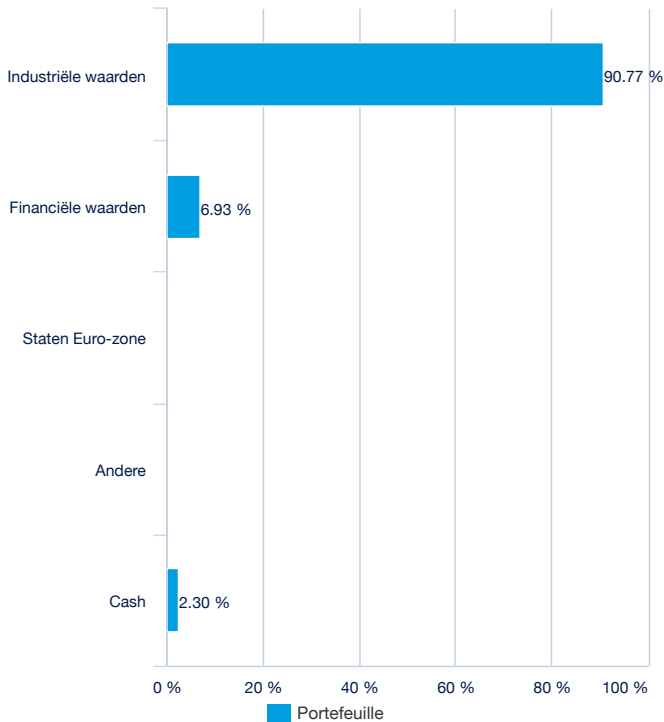

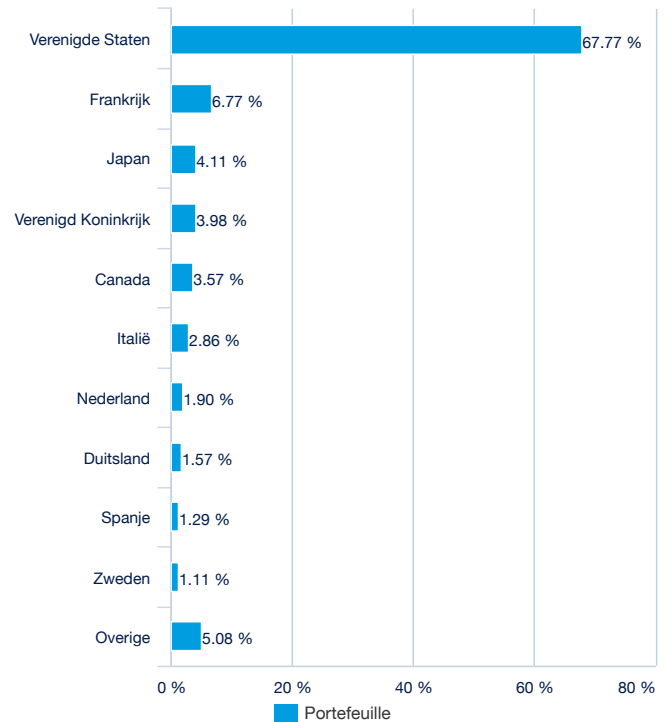
