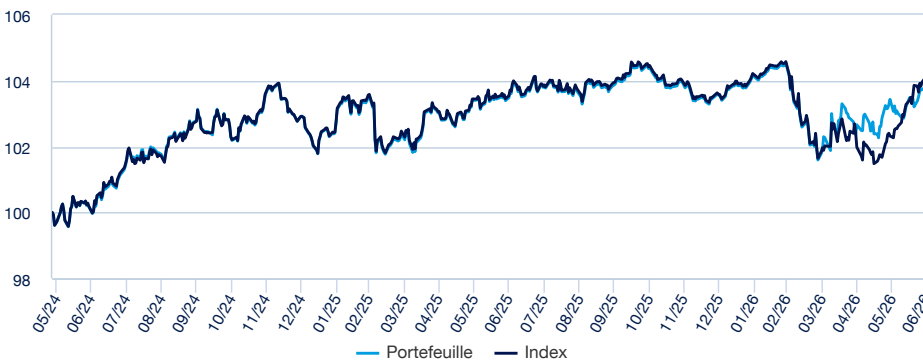

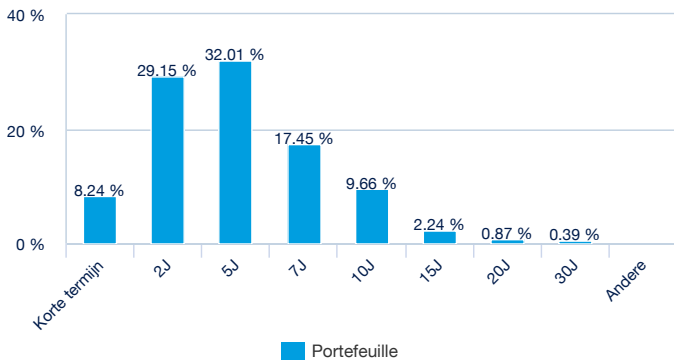

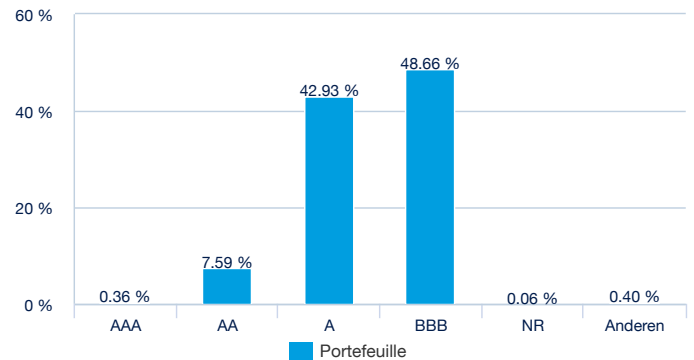

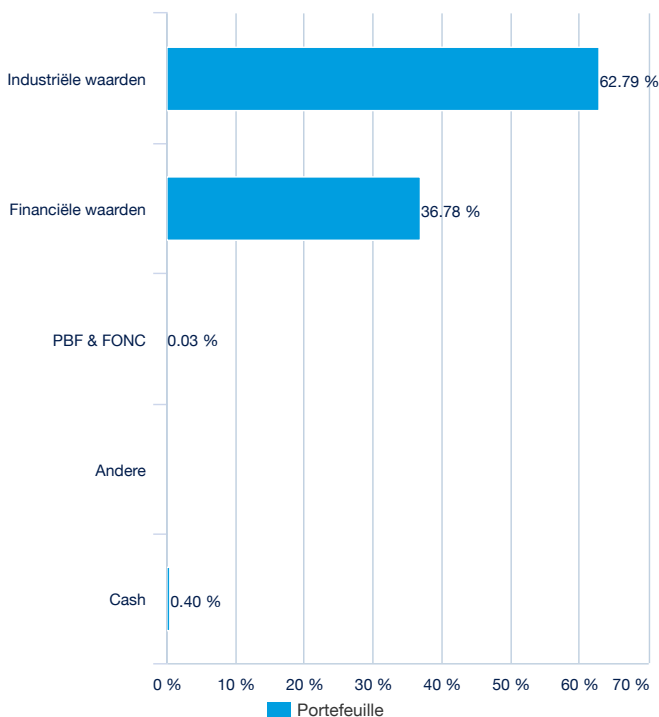
Per rijpheid (Bron: Amundi)



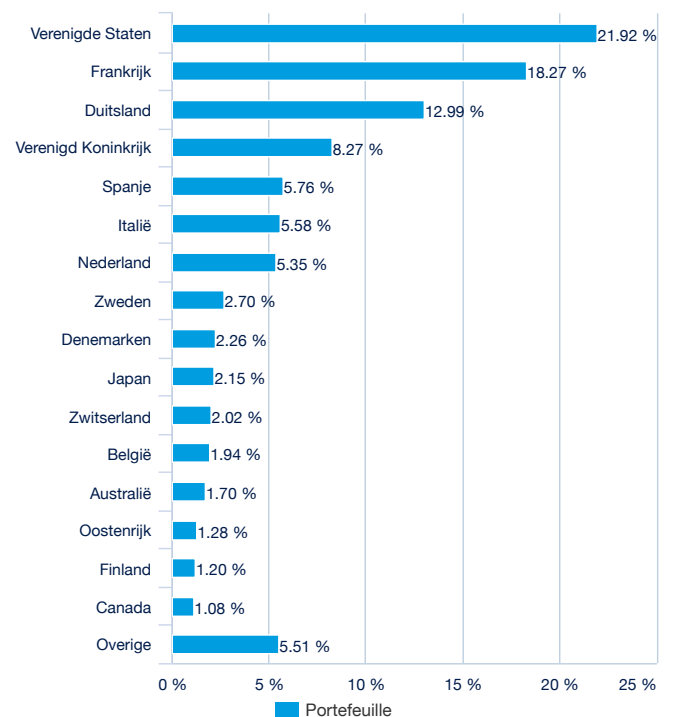
Per notatie (bron : Amundi)
