Beleggingsdoelstelling

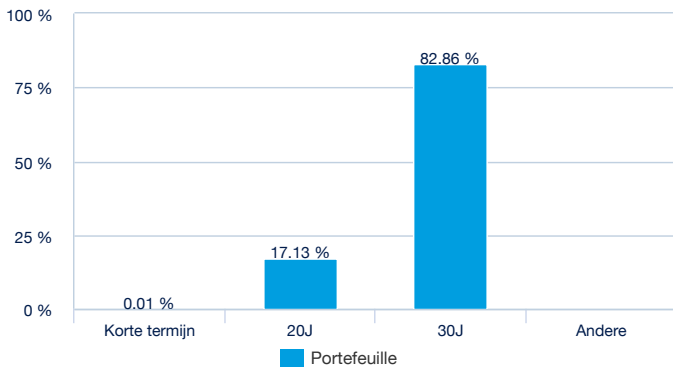

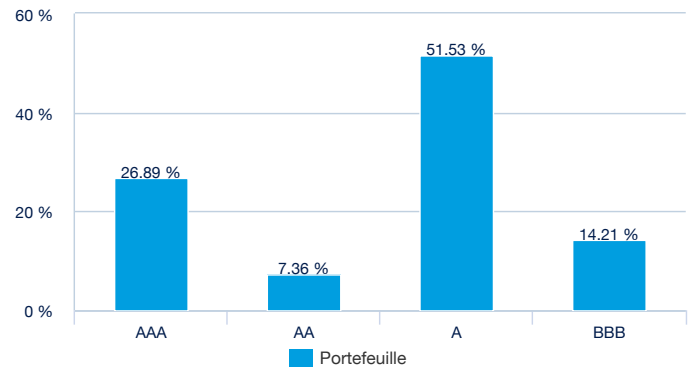

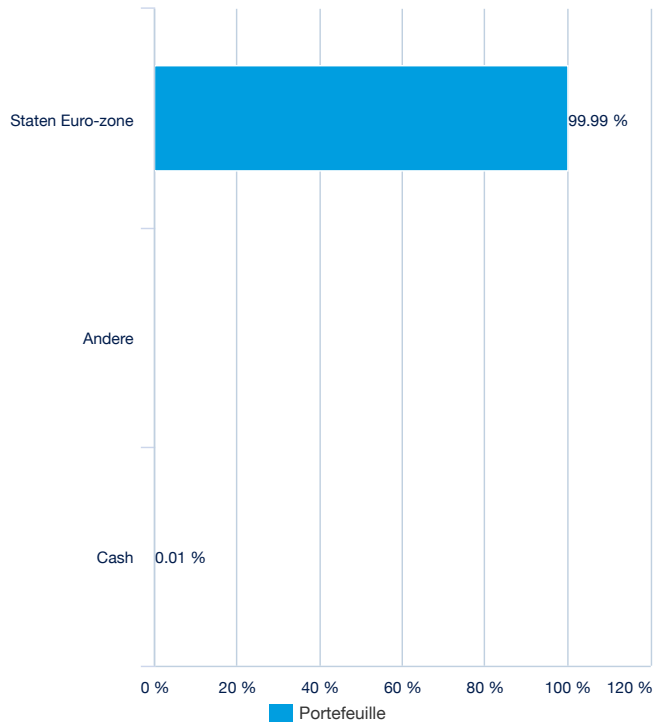

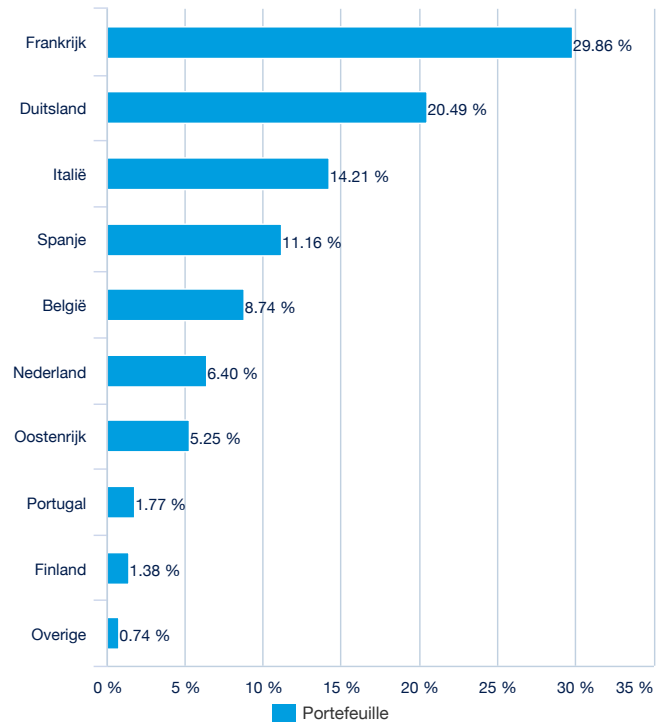
