Objective and Investment Policy

The investment objective of Amundi Core Global Inflation-Linked 1-10Y Bond (DR) UCITS ETF - Dist is to reflect the performance of the Bloomberg Barclays Global Inflation-Linked 1-10 Year Index Unhedged USD (the Benchmark Index) denominated in US Dollars and representative of the government local currency inflation-linked debt from developed market countries.

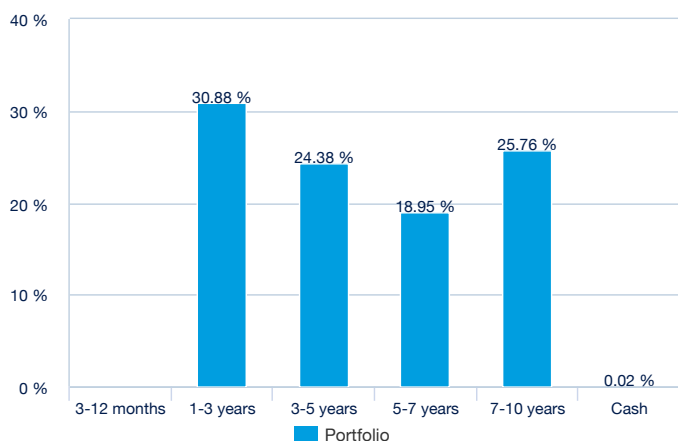

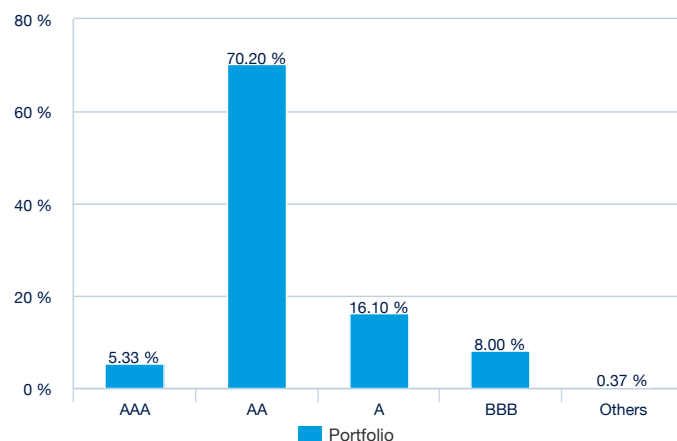

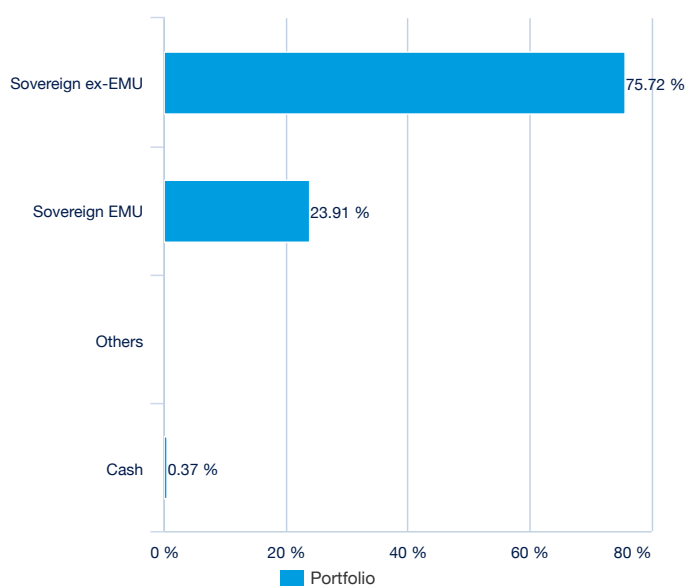
By maturity (Source: Amundi)



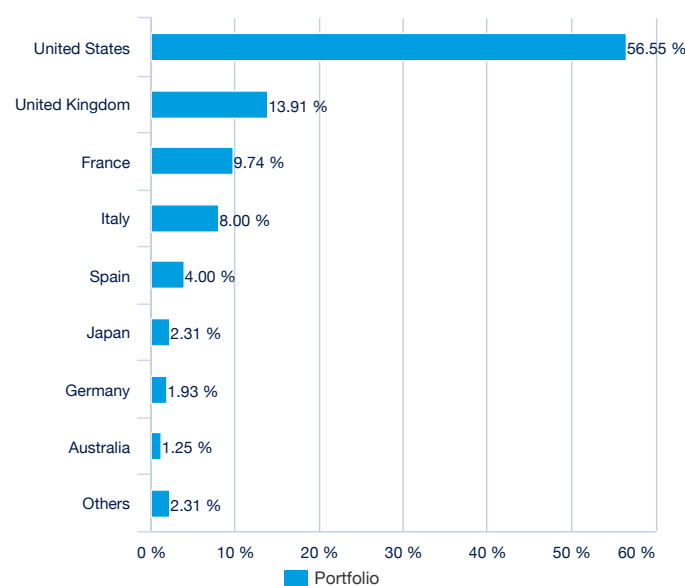
