Beleggingsdoelstelling

De beleggingsdoelstelling van het Fonds is het weerspiegelen van het rendement van de Bloomberg Euro Treasury 50bn 25+ Year Bond Index (de "Index") uitgedrukt in euro, en daarbij de volatiliteit van het verschil tussen het rendement van het Subfonds en het rendement van de Benchmark (de "Tracking Error") tot een minimum te beperken.

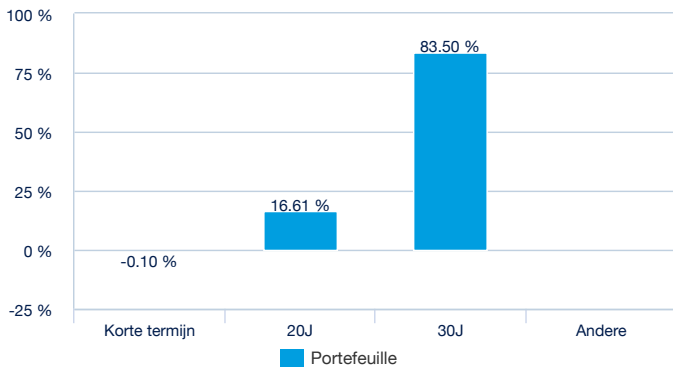

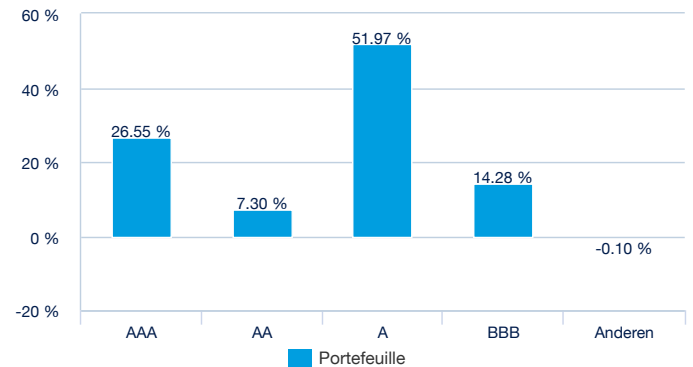

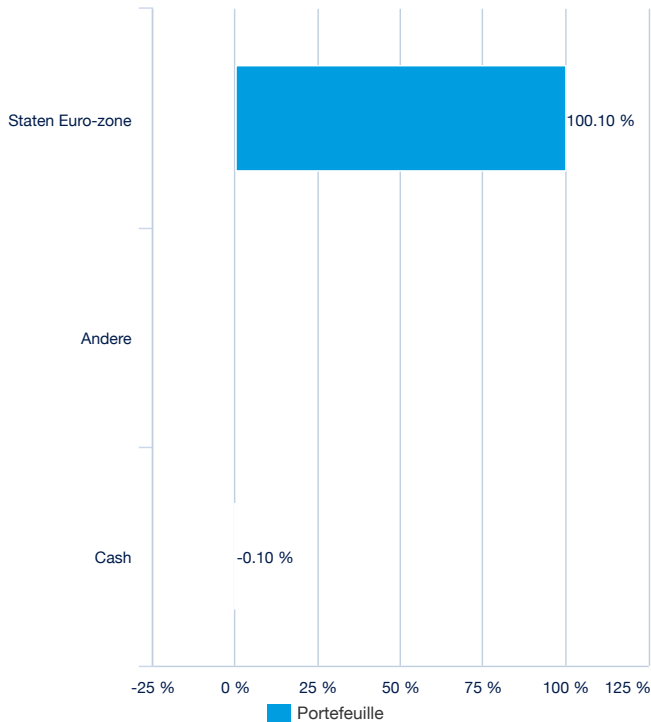

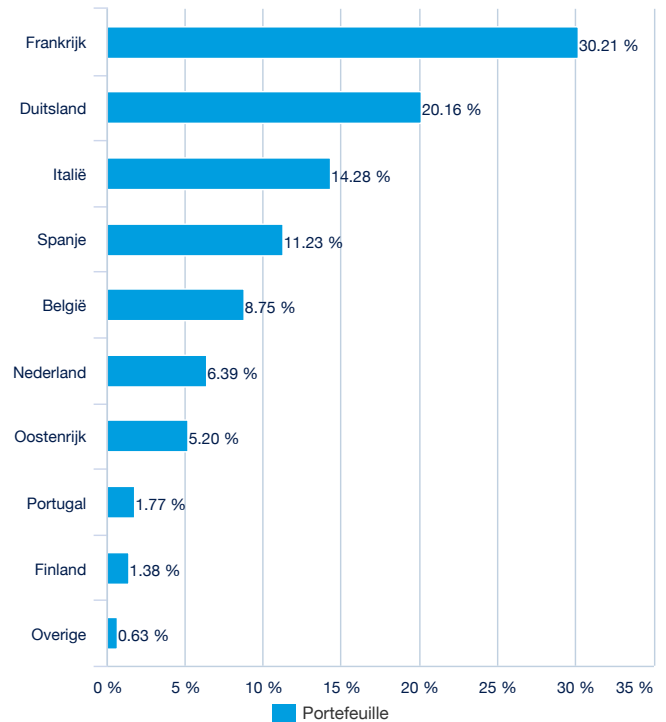
