Beleggingsdoelstelling

Het doel van dit Subfonds bestaat erin het rendement te volgen van de Bloomberg MSCI ESG US Corporate Select Index (de "Index") en de tracking error tussen de intrinsieke waarde van het subfonds en het rendement van de Index te beperken.

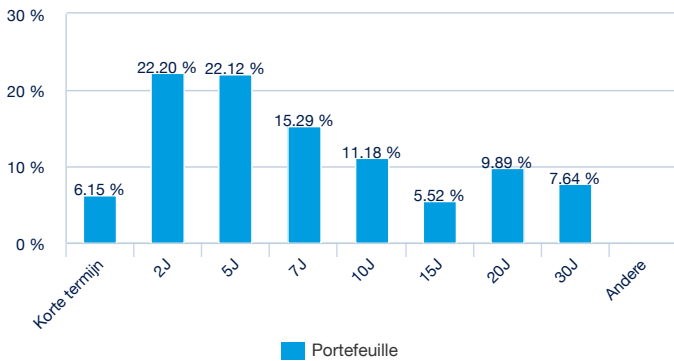

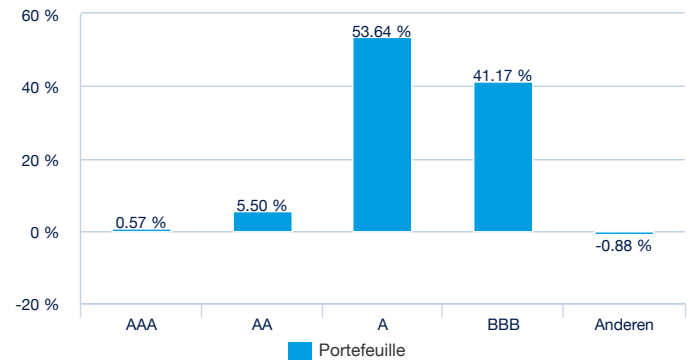

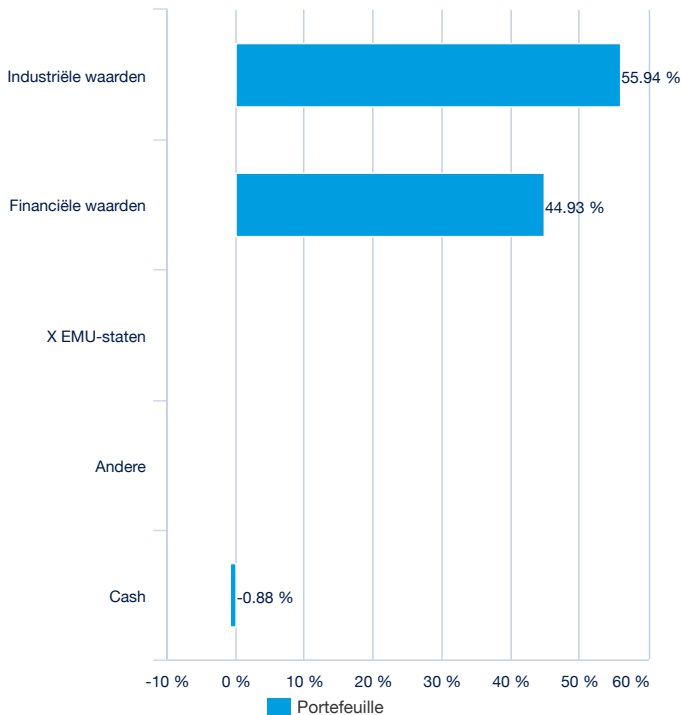

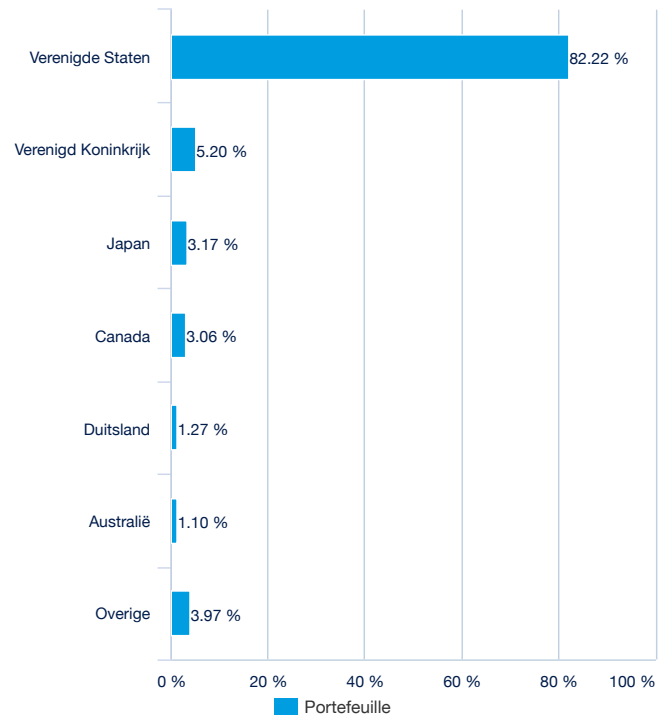
Per notatie (bron : Amundi)
