This ETF seeks to replicate as closely as possible the performance of the MSCI Emerging Markets Asia index whether the trend is rising or falling.

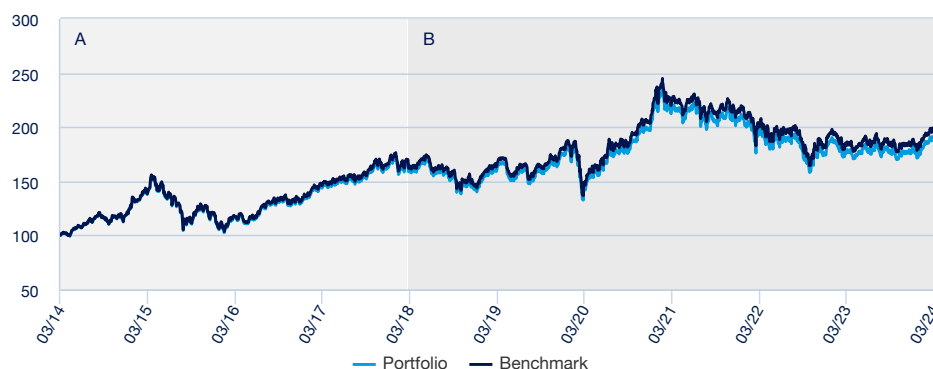

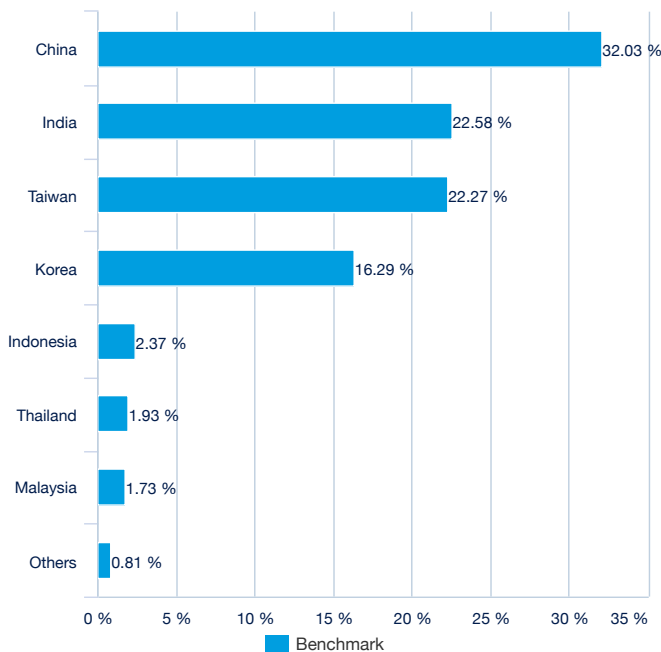

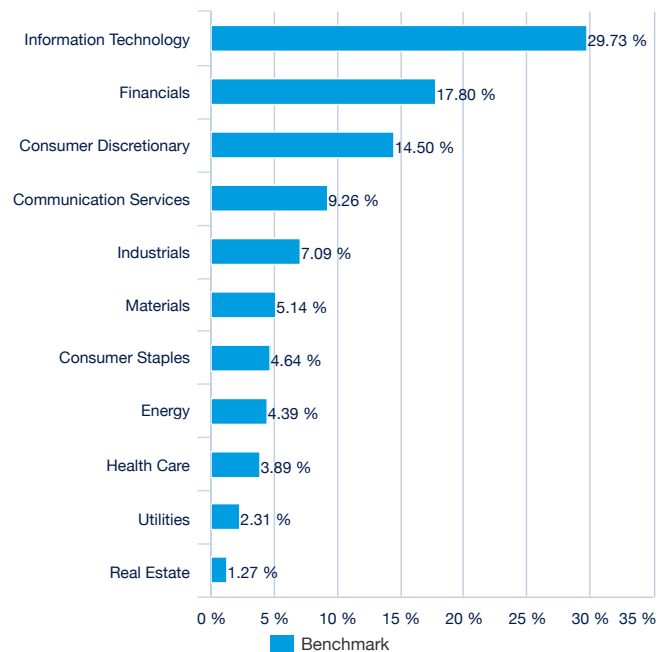
