This ETF seeks to replicate as closely as possible the performance of the S&P World Financials Screened Index (USD) index whether the trend is rising or falling.

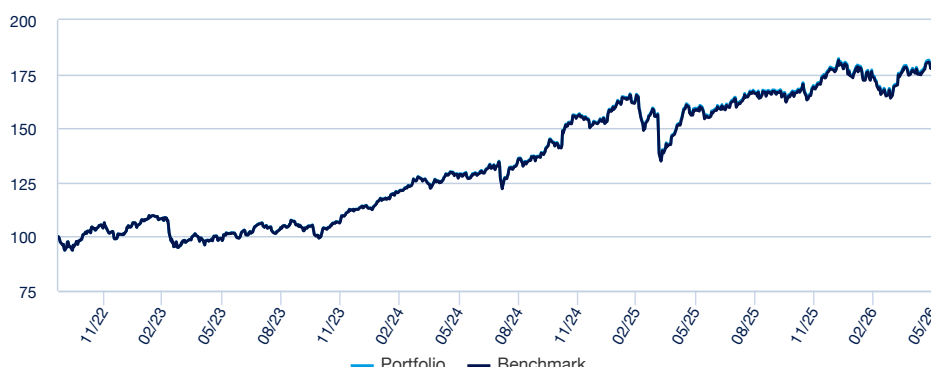

Description of the Index

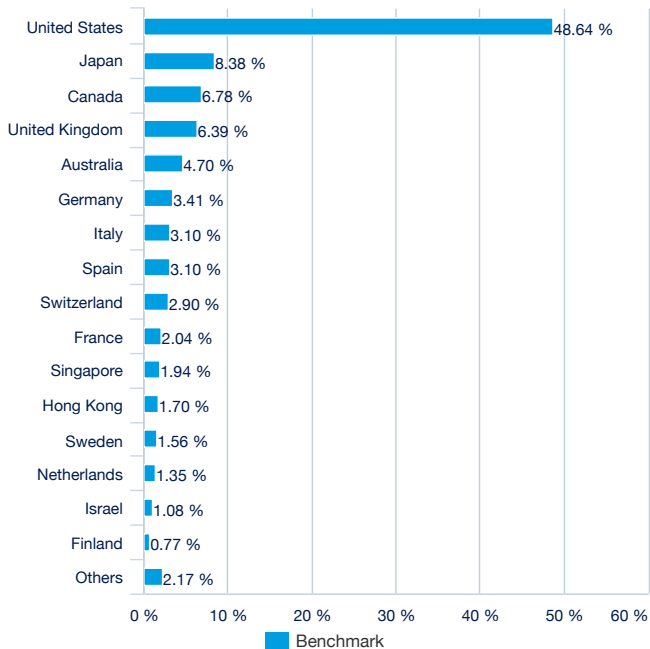

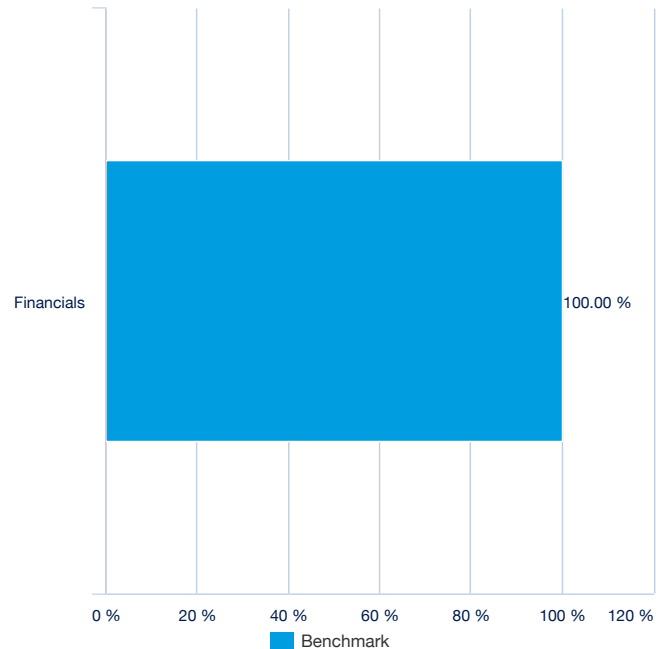
