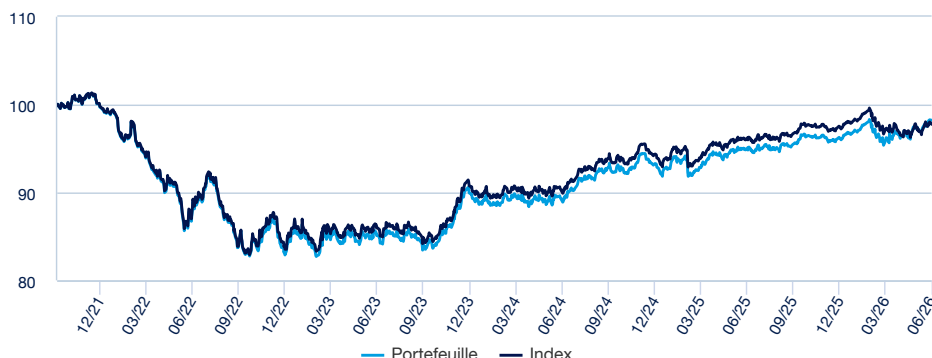

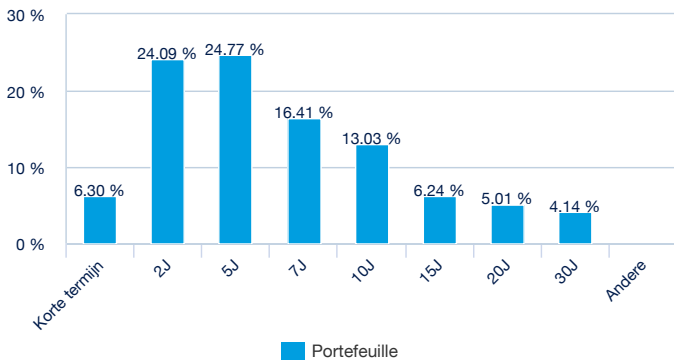

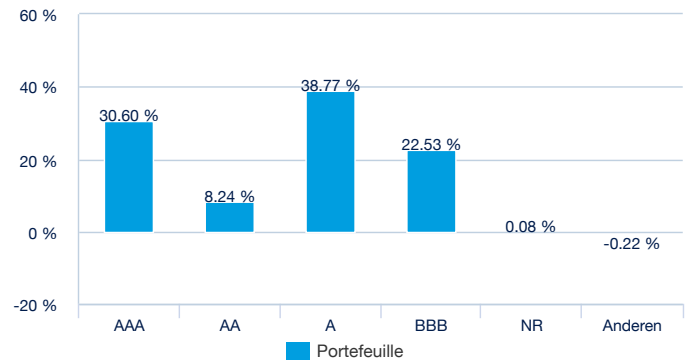

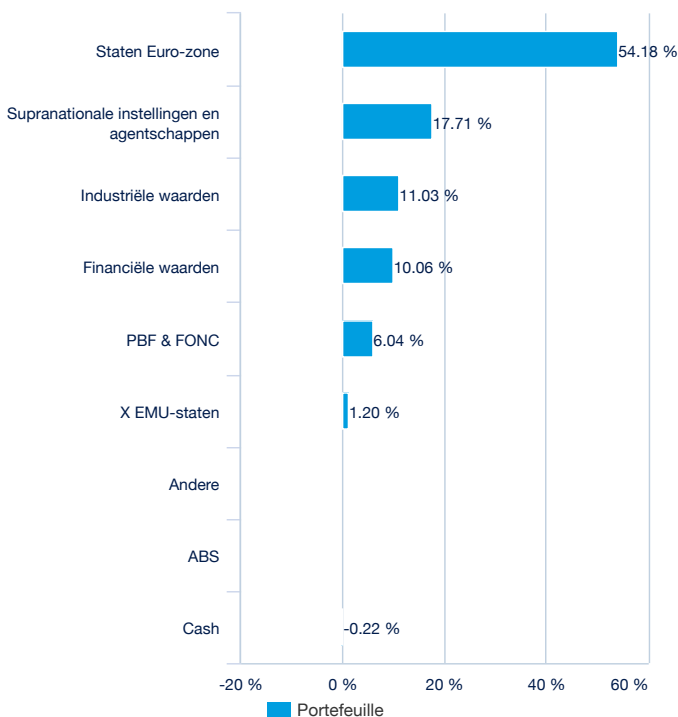
Per rijpheid (Bron: Amundi)



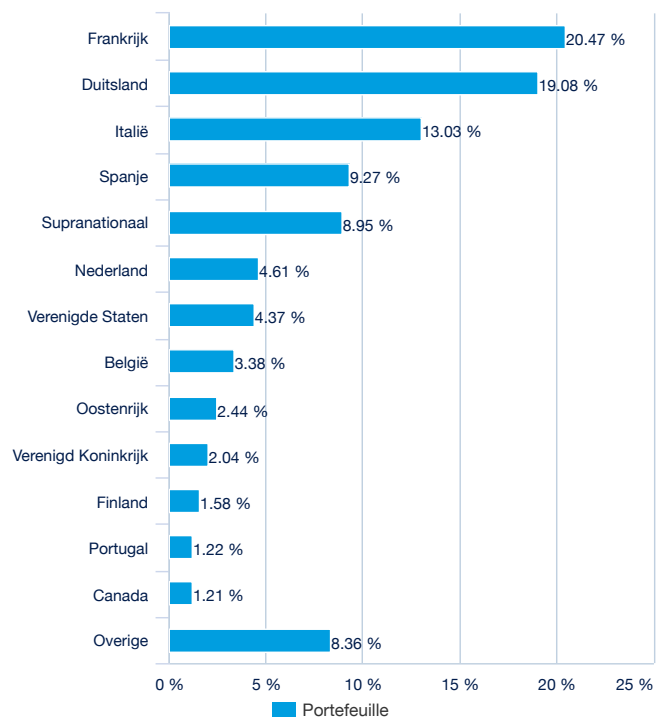
