Objective and Investment Policy

The Amundi Euro Government Bond 7-10Y (DR) UCITS ETF - Acc is a UCITS compliant exchange traded fund that aims to track the Bloomberg Barclays Euro Treasury 50bn 7-10 Year Bond Index.

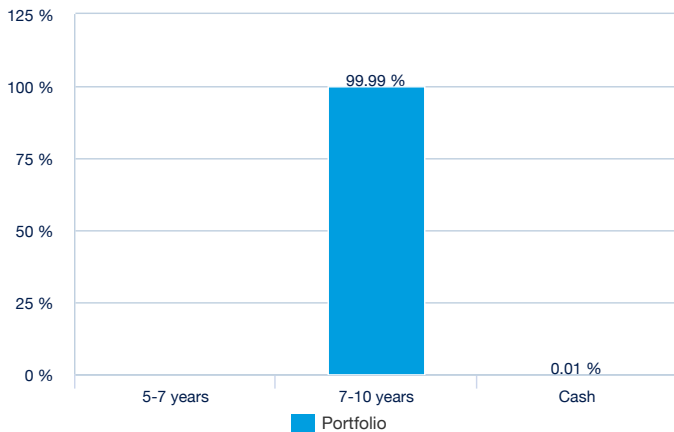

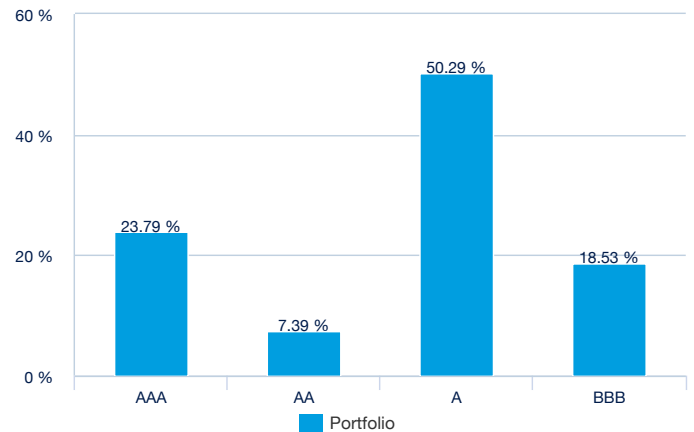

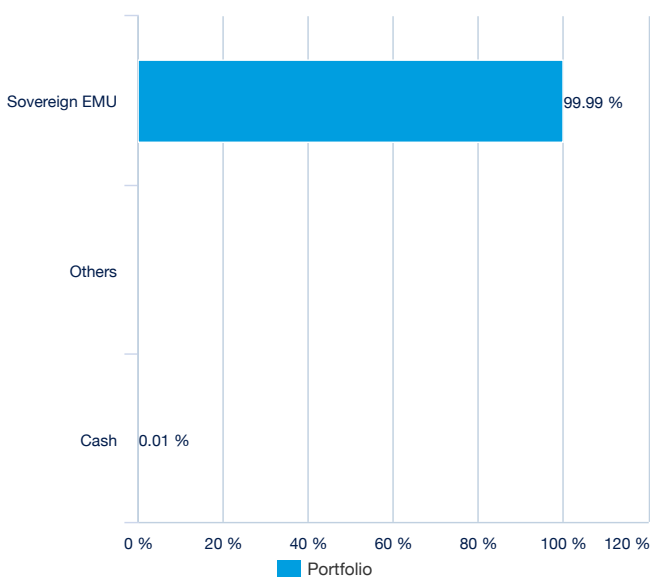
By maturity (Source: Amundi)



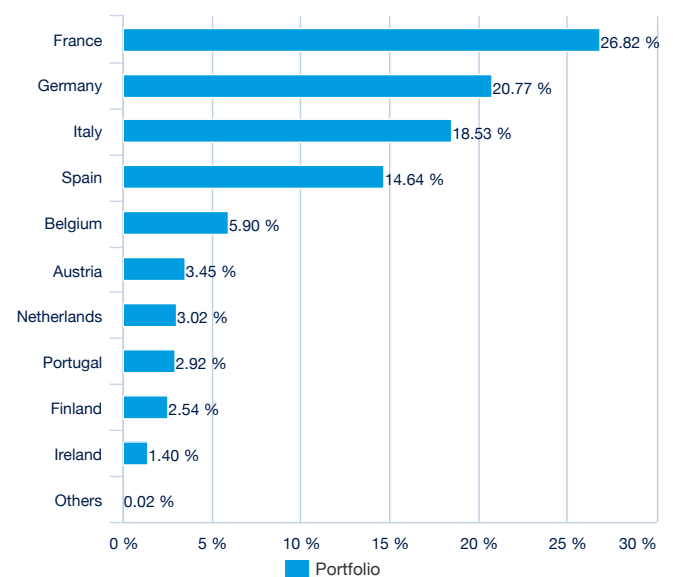
