Objective and Investment Policy

The objective of this Sub-Fund is to track the performance of the Solactive Eurozone Government Bond 0-1 Year Index (the "Index"), and to minimize the tracking error between the net asset value of the sub-fund and the performance of the Index. The Sub-Fund aims to achieve a level of tracking error of the Sub-Fund and its index that will not normally exceed 1%.

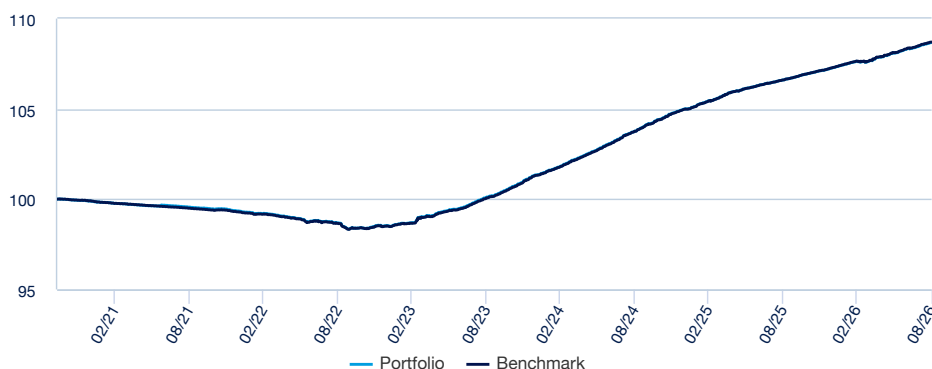

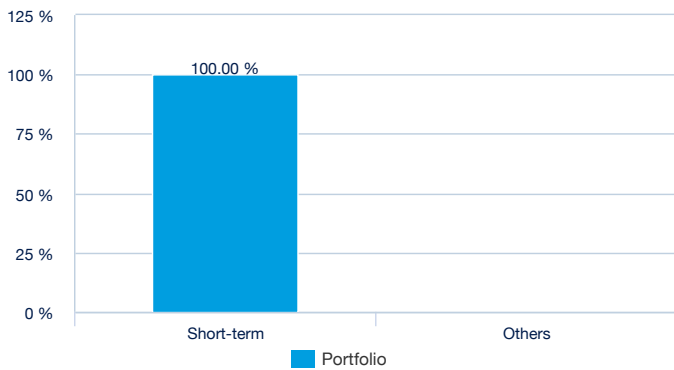

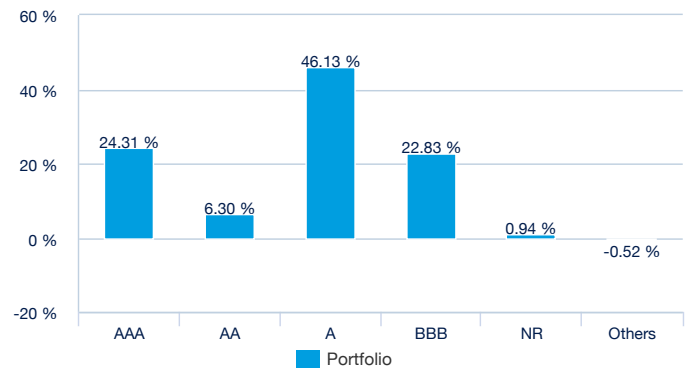

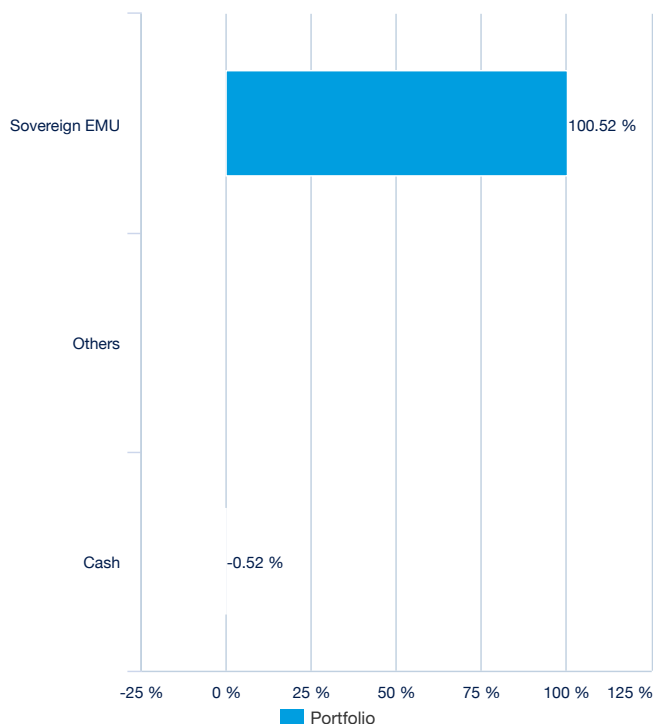
By maturity (Source: Amundi)



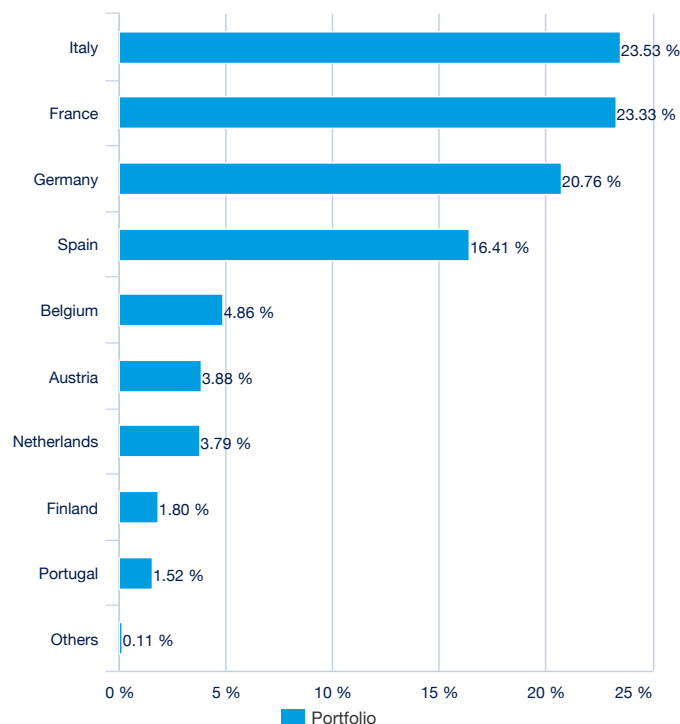
