Beleggingsdoelstelling

Het doel van dit Subfonds bestaat erin het rendement te volgen van de Bloomberg MSCI ESG Euro Corporate Select Index en de tracking error tussen de intrinsieke waarde van het Subfonds en het rendement van de Index te beperken. Het Subfonds streeft ernaar een tracking error tussen het Subfonds en zijn index te bereiken die normaal gezien niet meer dan 1% bedraagt.
De Index is een totaalrendementsindex: door de onderdelen van de Index betaalde coupons worden opgenomen in het rendement van de Index.
Bloomberg MSCI ESG Euro Corporate Select Index is een obligatie-index, representatief voor het in euro's luidende vastrentende effectenuniversum van beleggingskwaliteit dat de regels volgt van de Bloomberg Barclays Euro Aggregate Corporate Index (de "Moederindex"). Om in aanmerking voor selectie te komen, moet het effect aan de sector- en ESG-criteria voldoen.

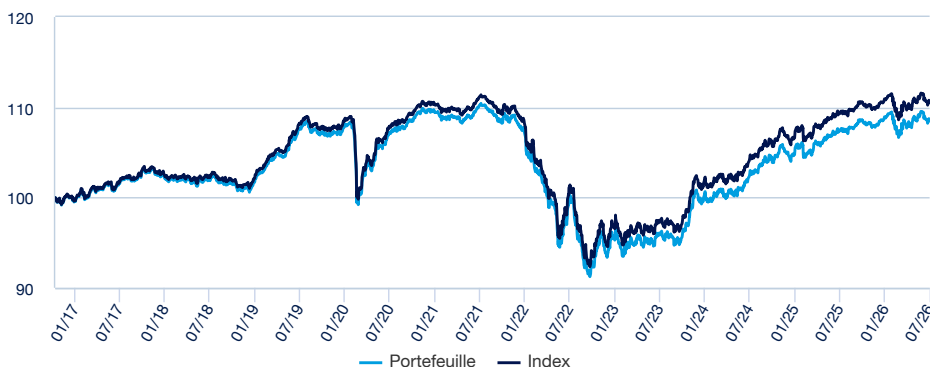

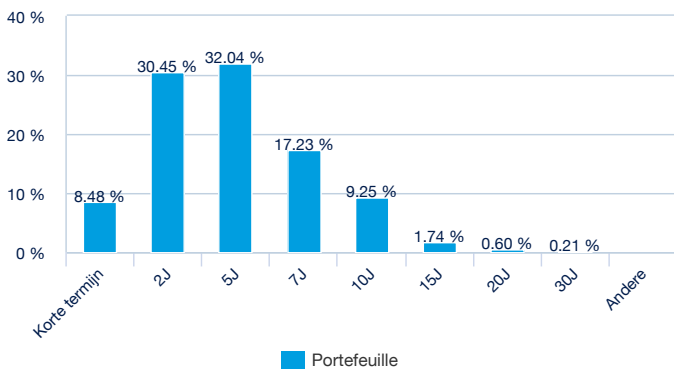

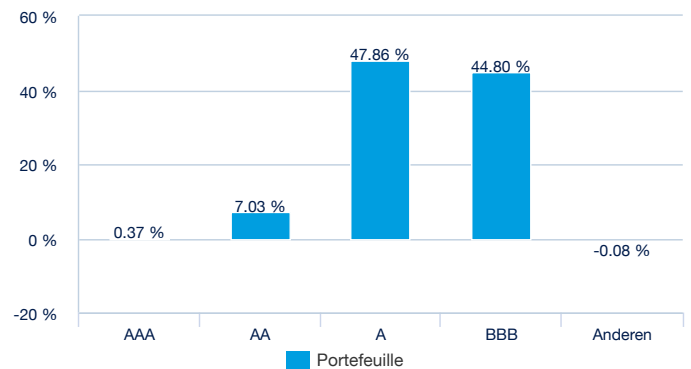

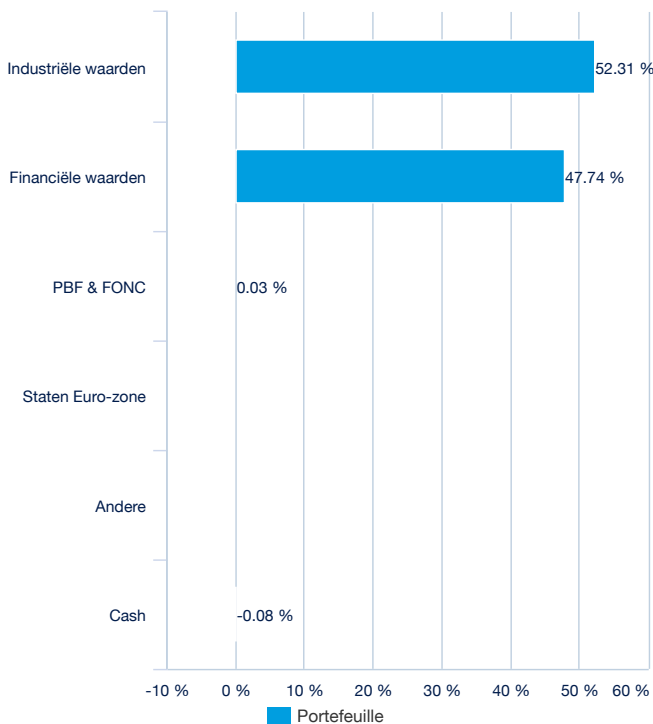

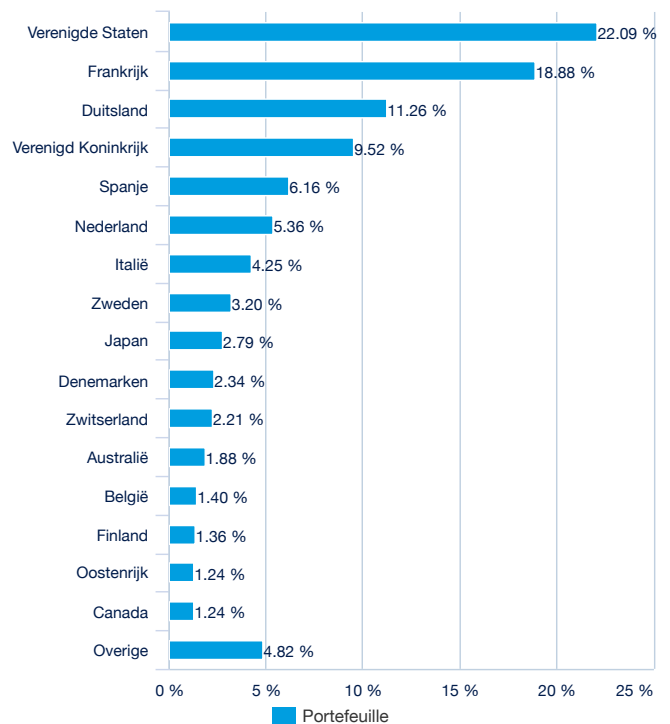
