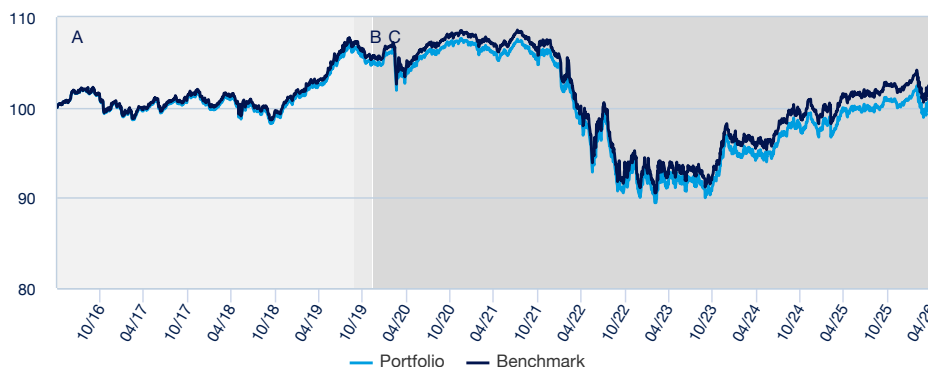

Description of the Index

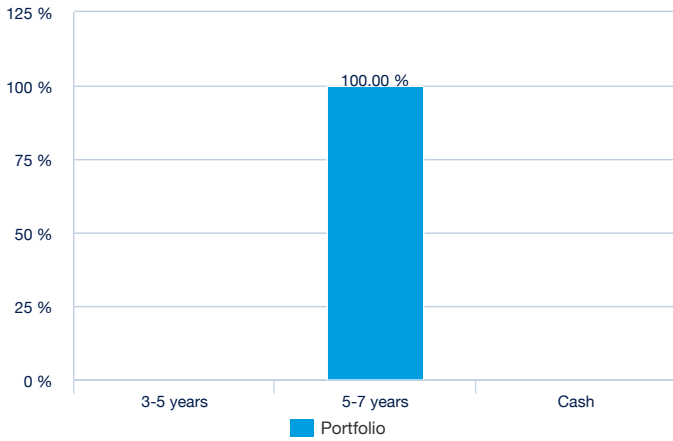

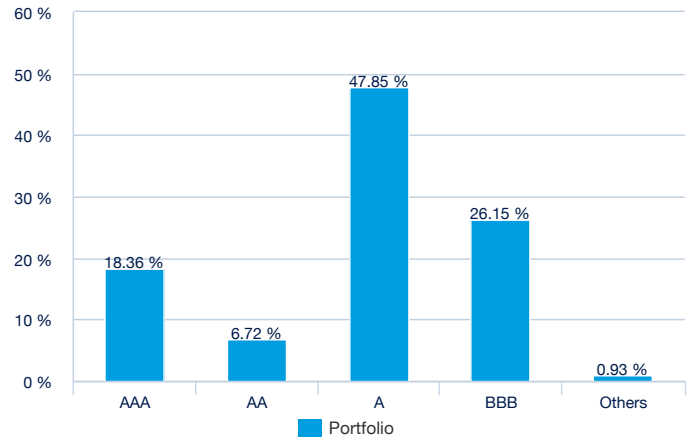

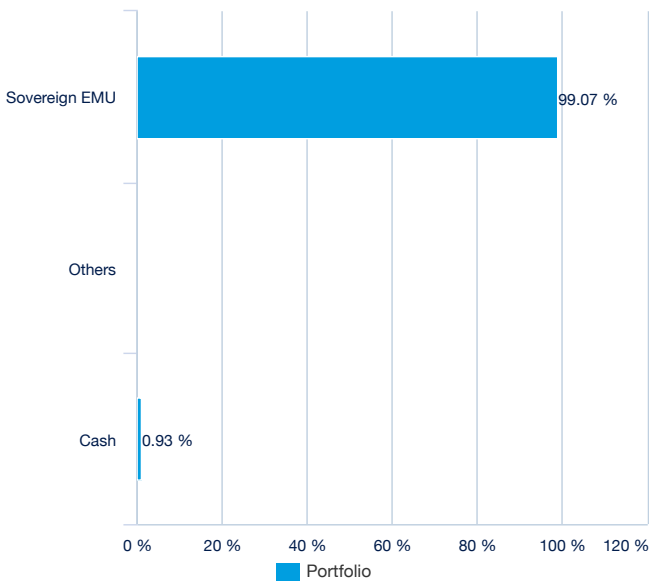
By maturity (Source: Amundi)



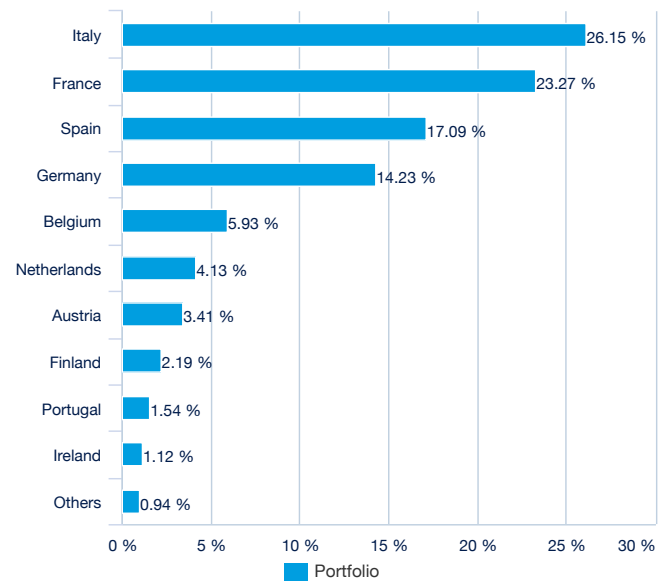
