This fund seeks to replicate as closely as possible the performance of the Bloomberg Global Aggregate (500 Million) index whether the trend is rising or falling.

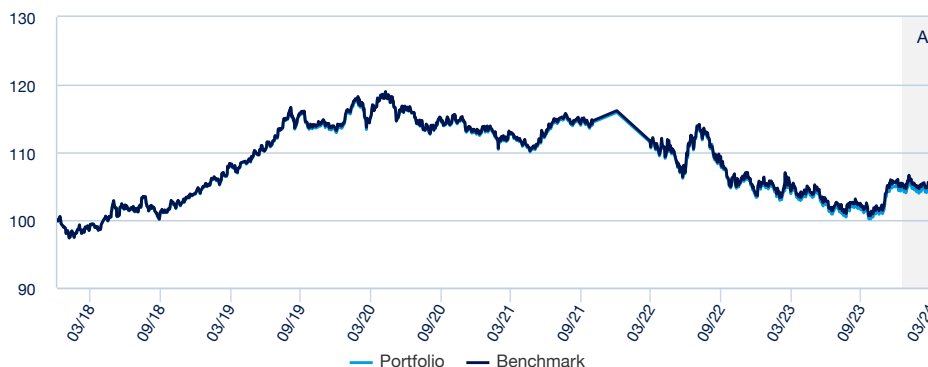

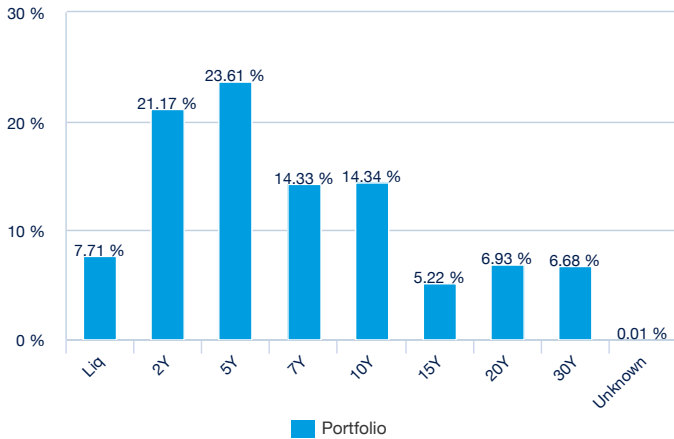

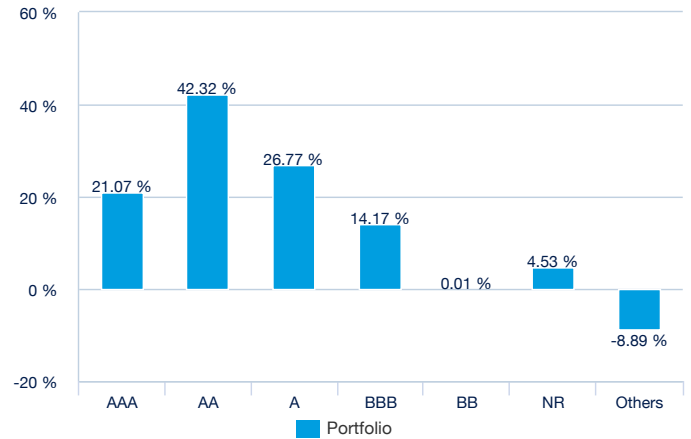

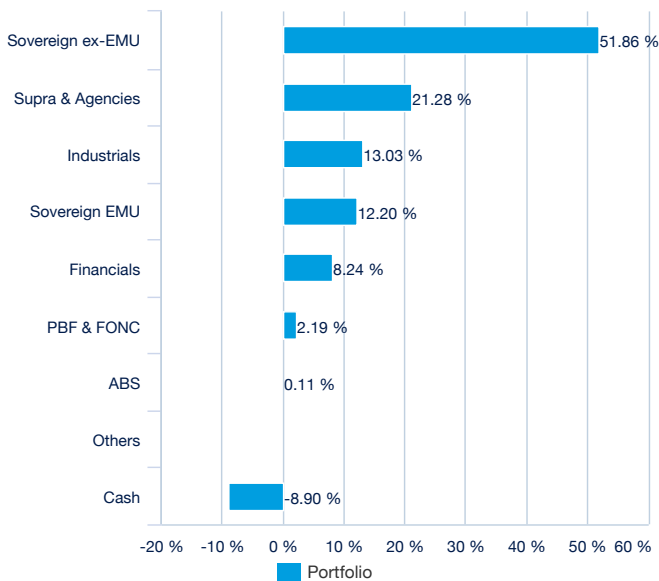
By maturity (Source: Amundi)



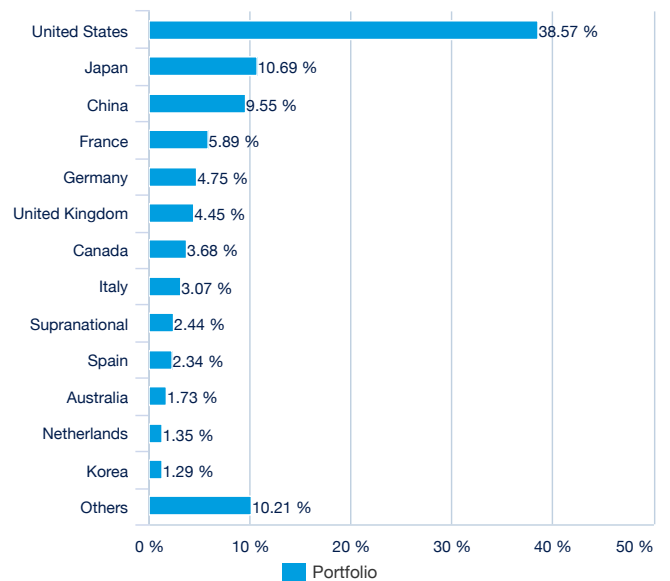
