What is this product?

Type: Shares of a Sub-Fund of Amundi Index Solutions, an Undertaking for Collective Investments in Transferable Securities (UCITS), established as a SICAV.

Term: The term of the Sub-Fund is unlimited. The Management Company may terminate the fund by liquidation or merger with another fund in accordance with legal requirements.

Objectives: The Sub-Fund is an index-tracking UCITS passively managed.

The objective of this Sub-Fund is to track the performance of the EURO STOXX Select Dividend 30 (Net Return) EUR Index (the "**Index**"), and to minimize the tracking error between the net asset value of the Sub-Fund and the performance of the Index.

The Sub-Fund aims to achieve a level of tracking error that will not normally exceed 1%.

The Index is a Net Total Return Index: dividends net of tax paid by the Index constituents are included in the Index return.

The Index is an equity index representative of the highest-yielding stocks relative to their home market within the Eurozone countries. The Index universe comprises all companies in the EURO STOXX Index that, inter alia, pay a dividend and show a non-negative historical dividend growth per share for the 5-year period as well as a non-negative pay-out ratio (ratio of the dividend to the profit per share) of no more than 60%. The EURO STOXX Index consists of the largest stocks of selected Eurozone countries and is part of the STOXX 600 Index. Components in the Index are weighted by their indicated annual net dividend yield.

What are the costs?

This product is designed for long-term investment; you should be prepared to stay invested for at least 5 years. You can redeem your investment at any time, or hold the investment longer.
