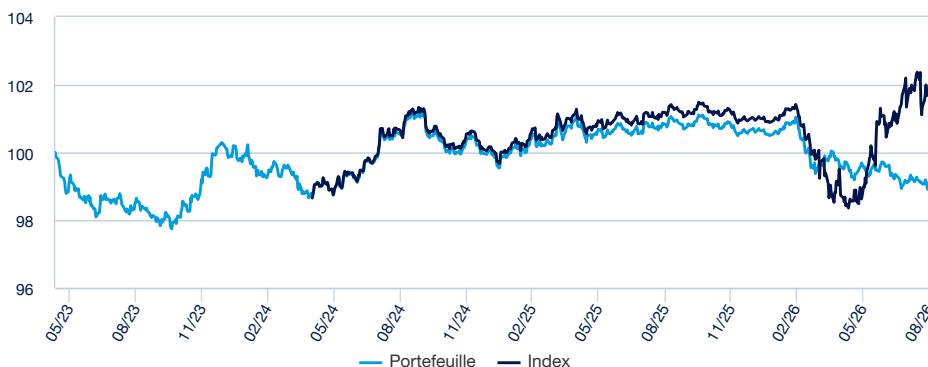

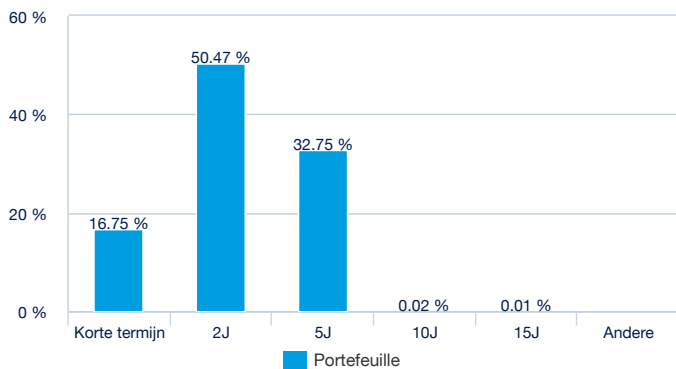

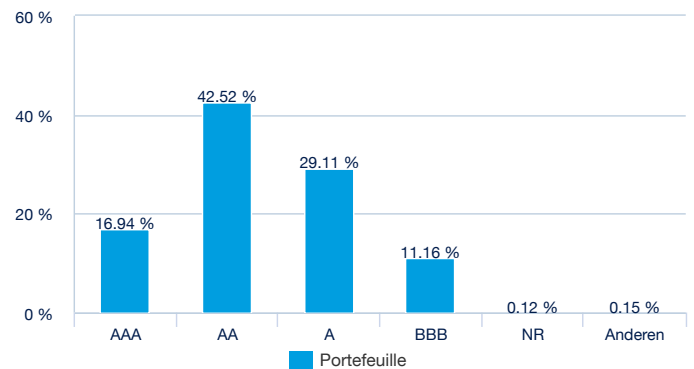

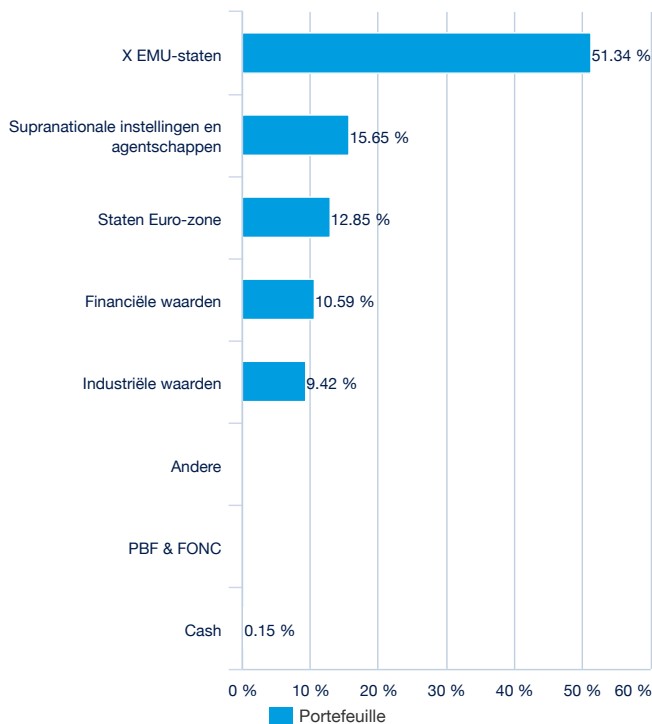

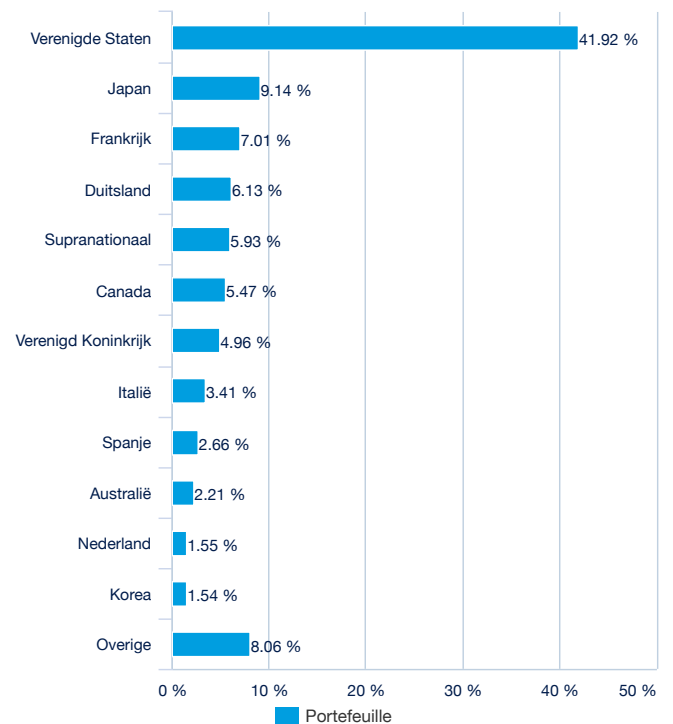
Per notatie (bron : Amundi)
