Beleggingsdoelstelling

Het doel van dit Subfonds bestaat erin het rendement te volgen van de Bloomberg Euro Treasury Low Duration Green Bond Tilted Index (de "Index"), en de tracking error tussen de intrinsieke waarde van het Subfonds en het rendement van de Index te beperken. Het Subfonds streeft ernaar een tracking error tussen het Subfonds en zijn index te bereiken die normaal gezien niet meer dan 1% bedraagt.

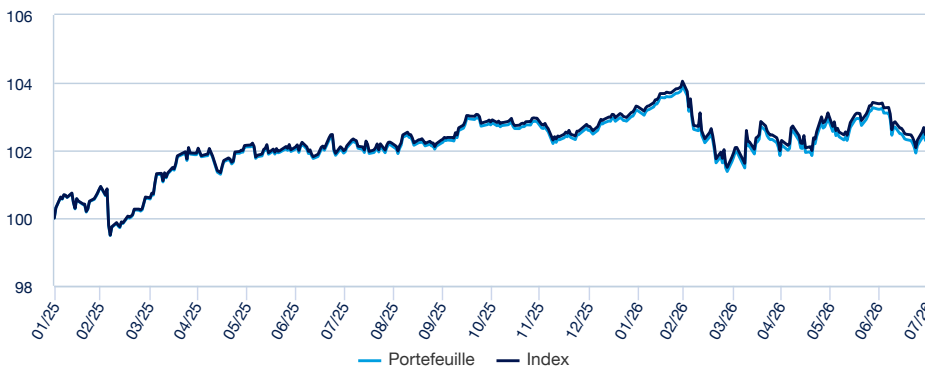

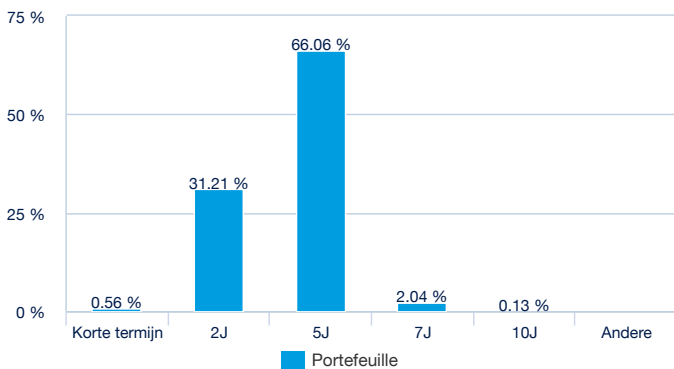

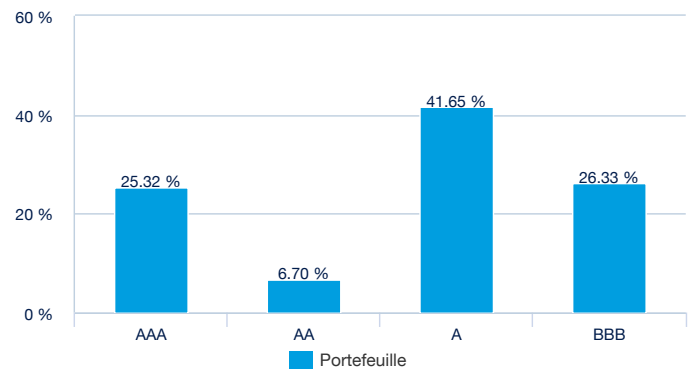

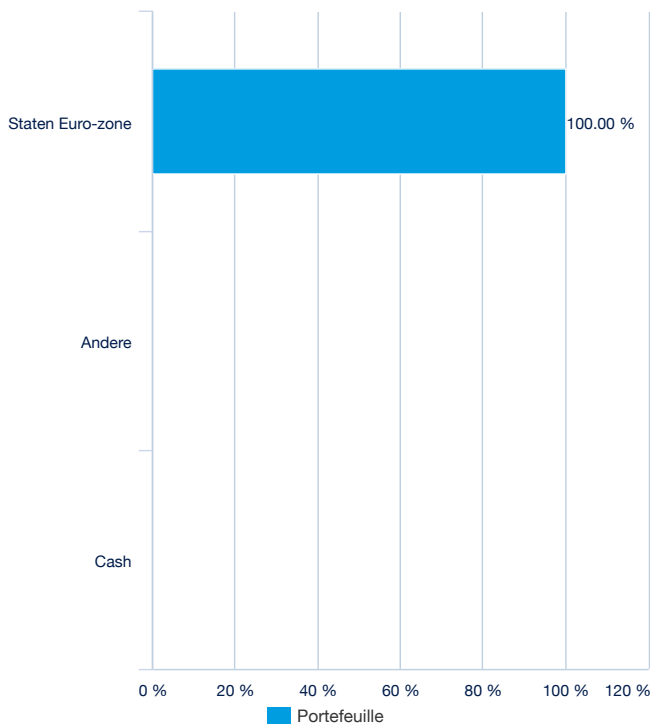
Per rijpheid (Bron: Amundi)



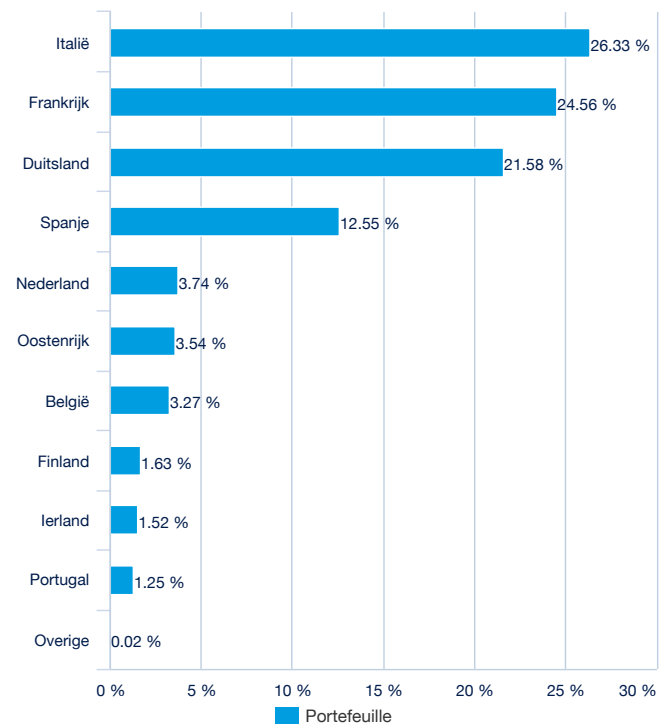
Per notatie (bron : Amundi)
