This ETF seeks to replicate as closely as possible the performance of the Bloomberg US Short Treasury index whether the trend is rising or falling.

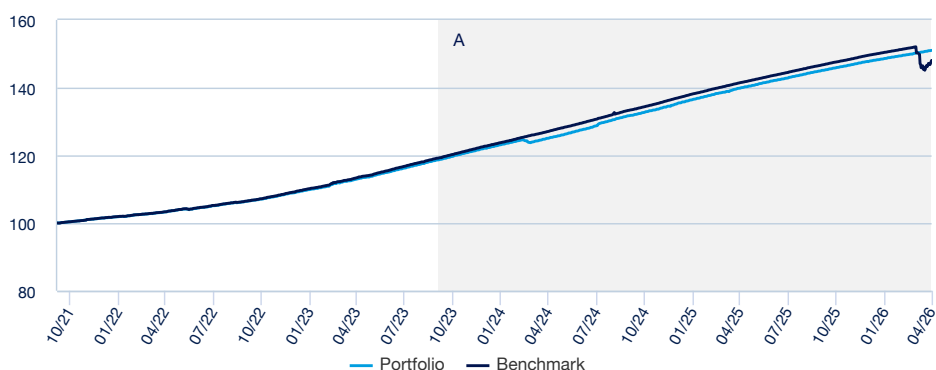

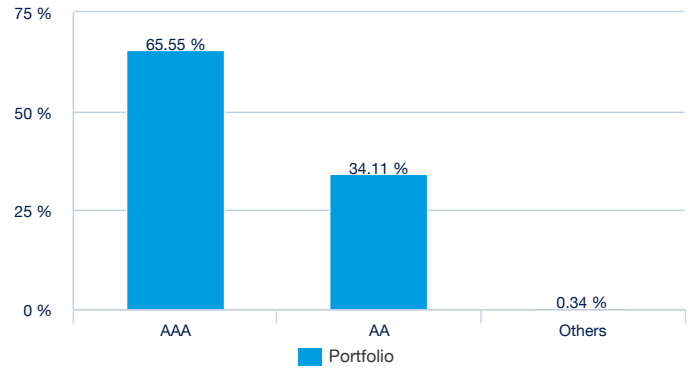

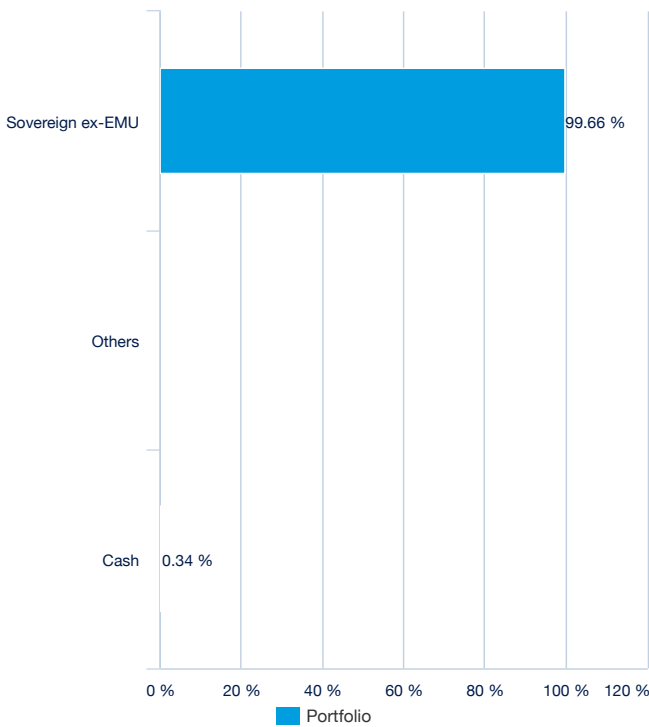

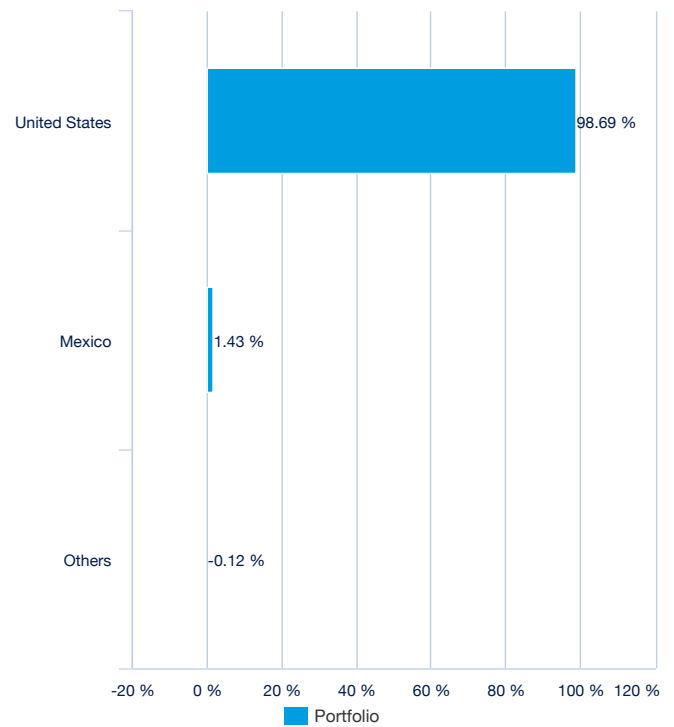
