This ETF seeks to replicate as closely as possible the performance of the S&P 500 index whether the trend is rising or falling.

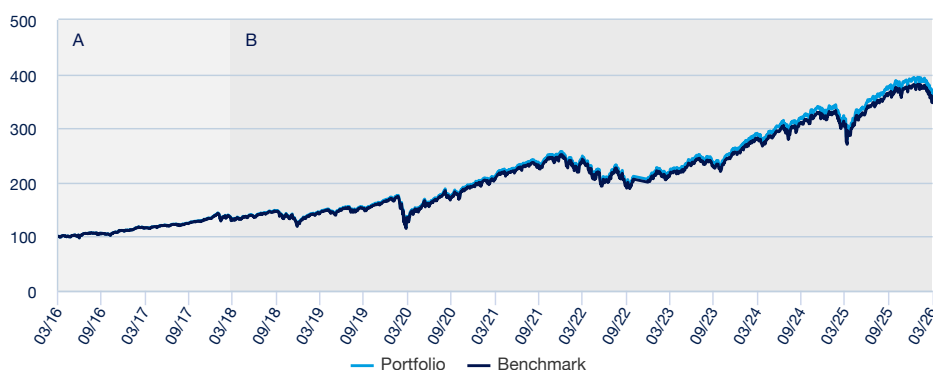

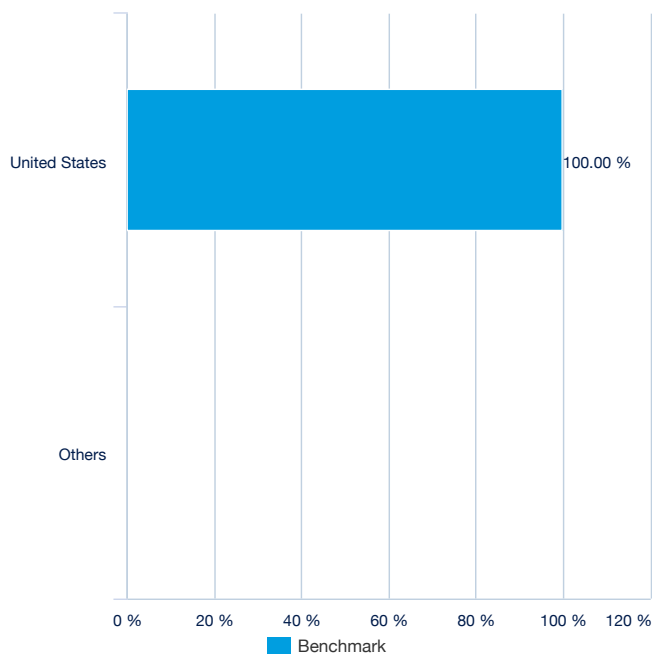

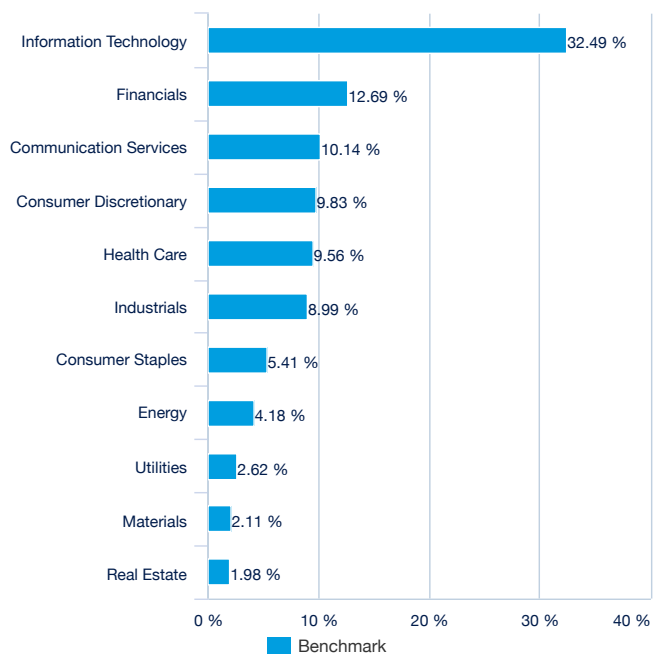
